Perluas Pasar Ritel Bekerja Sama dengan Bank BTPN



Jakarta, 11 September 2023 – Aktivitas perekonomian Indonesia mulai kembali bergairah. Badan Pusat Statistik mencatat pertumbuhan ekonomi triwulan II di angka 5,17 persen. Kembali normalnya mobilitas mendorong konsumsi masyarakat yang tumbuh 5,23 persen.

Jakarta, 11 September 2023 – Indonesia's economic activity is starting to rise again. Central Bureau of Statistics recorded economic growth in the second quarter at 5.17 percent. The return to normal mobility encouraged public consumption which grew by 5.23 percent.
